I. Welcome/Introductions – Katie Gallagher, Co-Chair (9:00am-9:10am)

- The meeting began at 9:02am. Katie welcomed everyone and asked them to introduce themselves.

II. Language Access Resource Center (LARC) – Eva Rafas, Senior Program Director, LARC (9:10am-9:20am)

- LARC is a non-profit organization, based in DuPage County, that offers free interpretation and translation services, an interpreter training program, informational workshops and various professional development opportunities.
 - Services are currently funded by two different grants:
 - (1) Grant from Milton Township's Mental Health Board to cover language services for any organization in or serving Milton Township
 - (2) Grant from Northwestern Medicine to cover language services for organizations and clients within the Central DuPage Hospital service area.
- LARC can assist clinical and non-clinical organizations that provide mental health and substance use services in the following ways:
 - **Interpretation Services:** Available in-person, virtual, and over the phone.
 - **Document Translation:** Translation for forms, documents, emails, flyers, subtitles, and more.
 - **Training Scholarships:** Scholarships are available for our Interpreter Training and Intro to Interpreting courses. A total of 10 (ten) seats are available. Open to residents or staff in the CDH service area that work or volunteer in traditional and non-traditional mental health services.
 - **Workshop:** About interpretation in mental health settings.
 - **Language Access Consultations:** Able to help with any other language access needs you might have.

III. Integrated Referral and Intake System (IRIS) – Kate Estrada, Community Initiatives Coordinator, DuPage County Health Department (9:20am-9:45am)

- Iris is a web-based, community-driven referral platform designed to streamline the process of connecting individuals with the services they need.
- IRIS facilitates secure, real-time referrals between organizations and capacity monitoring, ensuring a coordinated and efficient approach to care.
- By improving communication and tracking outcomes, IRIS enhances service coordination across sectors such as healthcare, social services, and education, ultimately helping communities provide better support to individuals and families.

IV. PLT Resource Guide Review – Lisa Lerner, Community Initiatives Coordinator, DuPage County Health Department (9:45am-10:15am)

- Lisa walked meeting attendees through two upcoming resources for PLT members – a parent communication guide about marijuana and a summary of 2024 IYS data.
 - The PLT has received several requests for presentations about how parents can talk to teens about using marijuana, so this guide was created to be shared with parents in DuPage County as a resource to guide them through the conversations.
 - Many partners use IYS data for grant applications, community presentations, and local messaging campaigns related to substance use and mental health. This one-pager would make it easier to share a summary of the data, rather than the whole report, and lead readers where to learn more.
